





JAIN CIRCUIT FROM MADURAI

Embark on a journey to Tamil Nadu and marvel at the abundance of Jainism-related sites dotting its landscape. Be captivated by the intricately crafted cave temples and reignite your spiritual bond by visiting the diverse abodes of Jain Tirthankaras.

PLACES COVERED:

Chithannavasal, Samanar Malai Pechipallam, Perumalmalai, Kongar Puliyankulam, Yanai Malai, Ladan Cave Temple, Kidaripatti, Thiruparankundram, Kazhugumalai, Madurai

ITINERARY:

Tamil Nadu was once a thriving center for Jainism, and its influence can be seen in various Sangam literary works. During this heritage trail, we will explore the intricately crafted cave temples and the holy sites devoted to Jain Tirthankaras.

Day 1:

Departing early in the morning from HOTEL TAMILNADU Madurai, we will drive towards Chithannavasal Cave, which carries the fascinating frescos done by Jain monks. We will have lunch at HOTEL TEMPLE CITY on the way and later that evening we will reach Samanar Malai, and then proceed towards Pechipallam, Perumalmalai, and Kongar Puliyankulam, which is adorned with sculptures and inscriptions. We will have dinner and halt for the night at HOTEL TAMILNADU Madurai.









Day 2:

After breakfast, we start the day by visiting Yanai Malai, and then proceed towards Ladan Cave Temple for sightseeing, which has sculptures of Jain Monks with Shaivaite & Vaishnavite temples at close proximity. After having lunch at HOTEL TEMPLE CITY, we will reach Kidaripattia quaint village with remnants of Jain idols and then proceed towards Tiruparankundram. We'll halt for the night at HOTEL TAMIL NADU Madurai.

Day 3:

After breakfast, we will visit Kazhugumalai, which holds statues of important Tirthankaras like Gomateswara, and Parshvanatha. After that we will visit Vettuvan Koil and have our lunch at TEMPLE CITY. We'll drive back to Madurai and complete the heritage trail.

Cancellation Rules - Tours

- 1. No cancellation is permissible within 24 hours of tour commencement.
- 2. Online tour package reservations can be cancelled via TTDC website.
- 3. For online bookings, one will receive a refund based on the cancellation rules.
- 4. The refund amount will be credited to the source account used for the transaction while booking.
- 5. The amount is non-refundable, if the tourist misses the coach or cancels the journey after the departure of the coach.
- 6. Cancellation charges will be levied as mentioned below.


Within 48 to 24 Hours: 50%

Before 48 Hours: 75%.

- 7. Prior to 24 hours, only one preponement/postponement is permitted, subjected to the availability of accommodation.
- 8. No Cancellation/Preponement/Postponement is allowed after availing of one postponement or preponement.
- 9. 2% of transaction charges will be levied on every cancellation.
- 10. 18% GST will be deducted from cancellation charges.
- 11. If the booking is made through the agents, the cancellation also should be done through them.

General Rules - Tours

- 1. The tours will be subjected to operational conditions. The ticket is non-transferrable. There will be no refund for any unforeseen calamities, which may occur during the tour.
- 2. TTDC will not be responsible for any damage or loss to the properties of the tourists.
- 3. If a person travels as a single entity, he/she will be accommodated in a single room during night halts on the purchase of a single room accommodation ticket.
- 4. Three adults in a family will be accommodated in one double room with a provision of one extra mattress.
- 5. Additional mattresses will be provided only for child tickets in package tours. The programme and tariff are subjected to change.
- 6. Tours will be operated with a minimum number of 10 tickets.
- 7. Due to administrative reasons, the tours will be operated with a 10 seater/18 seater/35 seater coaches.
- 8. All disputes will be under the Chennai Jurisdiction.
- 9. The rates are subjected to change at any time without notice.
